2. Variance: 2353 Jones Avenue

THAT the application of Randall Wong, Owner, representing the owners of 2353 Jones Avenue, North Vancouver, BC, and legally described as Lot 11, Block 212, DL 544, Plan 2838, requesting a variance to "Zoning Bylaw, 1995, No. 6700", Part 5: "Residential Zone Regulations":

- Section 509(5) "Siting (Principal Building)" (d) be varied to reduce the required 3.04 meters (9.98 feet) setback from the Exterior Side Lot Line to 1.16 meters (3.8 feet) for the wall of the Principal Building and attached basement storage room to the Exterior Side Lot Line (West 24th Street);
- Section 410 Siting Exceptions (1) (b) (ii) be varied to permit the eaves and gutters to project beyond the face of the Principal Building by 0.49 meters (1.6 feet) to the Exterior side lot line thereby allowing the eaves and gutters on the Principal Building to be setback 0.67 meters (2.2 feet) from the Exterior Side Lot Line (West 24th Street); and

3. Section 410 Siting Exceptions (1) (e) (ii) be varied to permit the unenclosed front porch attached to the Principal Building to be setback a minimum of 1.16 meters (3.8 feet) to the Exterior Side Lot Line (West 24th Street);

be **GRANTED** as per the plans submitted to the City of North Vancouver dated February 8, 2017.
