**BYLAW NO. 8056**

**A Bylaw to provide for the payment of annual indemnity, remuneration, and acting pay to the Mayor and Councillors of The Corporation of the City of North Vancouver effective January 1, 2010.**

The Council of The Corporation of the City of North Vancouver, in open meeting assembled, enacts as follows:

1. This Bylaw shall be known and cited for all purposes as “**Council Indemnity Bylaw, 2009, No. 8056**” (Council Indemnity effective January 1, 2010).
2. Until the IAFF Local 296 have settled their contract, the annual indemnity for the Mayor, Councillors and Acting Mayor, to be paid out of the annual revenue of the said Corporation, shall be based on the CUPE 389 contract alone and increased by 2% effective January 1, 2010, as follows:
  - (a) To the Mayor of the City as an annual indemnity the sum of:  
\$91,495
  - (b) To each Councillor of the City as an annual Indemnity the sum of:  
\$31,651
  - (c) The annual indemnities herein provided will be paid in 26 bi-weekly installments.
3. One-third of the sum of \$91,495 to be paid to the Mayor as aforesaid, shall be paid as an allowance for expenses incidental to the discharge of the duties of the office as an elected Mayor of the City, and one third of the sum of \$31,651 to be paid to each Councillor as aforesaid, shall be paid as an allowance for expenses incidental to the discharge of the duties of the office as an elected Councillor of the City and one-third of the monthly sum of \$1152 paid to Councillors for acting pay shall be paid as an allowance for expenses incidental to the discharge of duties of the office of Acting Mayor.
4. That in consideration of the role and responsibilities carried out by the Acting Mayor, monthly compensation of \$1152 for the Acting Mayor be paid effective January 1, 2010.

Each Councillor will receive the acting pay for a two month period as per the following schedule:

**Appointment of Acting Mayors**

Councillor R.C. Clark.....	December - January
Councillor C.R. Keating.....	February - March
Councillor P.J. Bookham.....	April - May
Councillor R.G. Heywood.....	June - July
Councillor M.L. Trentadue.....	August - September
Councillor R.J. Fearnley.....	October - November

5. Bylaw No. 7982, known as “Council Indemnity Bylaw, 2008, No. 7982”, and all its amendments thereto, is hereby repealed.
6. This Bylaw shall be effective upon the date of adoption.

READ a first time by the Council on the 7<sup>th</sup> day of December, 2009

READ a second time by the Council on the 7<sup>th</sup> day of December, 2009.

READ a third time and passed by the Council on the 7<sup>th</sup> day of December, 2009.

RECONSIDERED and finally adopted by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal on the 14<sup>th</sup> day of December, 2009.
