THE CORPORATION OF THE CITY OF NORTH VANCOUVER

BYLAW NO. 3282

A bylaw to prohibit the discharging of firearms, air guns, air rifles or pistols and spring guns.

The Council of The Corporation of the City of North Vancouver in open meeting assembled enacts as follows:

1. The discharging by any person of any firearm, rifle, shotgun, air gun, air rifle, air pistol or spring gun within the limits of the Corporation of the City of North Vancouver is hereby prohibited, unless authorized in writing by the Chief of Police of the City of North Vancouver. *[Bylaw 5391, January 11, 1982]*
2. This bylaw is applicable throughout the said Municipality.
3.
 - (a) Any person who violates any provision of this bylaw shall be deemed to be guilty of an offence against this bylaw and shall be liable on conviction thereof to a penalty not exceeding \$100.00 with the costs of prosecution.
 - (b) Any Justice of the Peace or other Court before whom the prosecution is had for an offence against this bylaw may convict the offender on the oath or affirmation of any credible witness, and may impose the whole or part of the penalty or punishment authorized by this bylaw with the costs of prosecution.
 - (c) In the event that the penalty, or part of the penalty, and costs imposed under this section are not paid forthwith, the Justice of the Peace or other Court before whom the prosecution was had, may, by warrant under the hand and seal of the Justice or other Court, or in case two or more Justices act together therein, then under the hand and seal of one of them., cause the penalty and costs, or part of the penalty and costs, to be levied by distress and sale of the goods and chattels of the offender; and in the case of there being no distress found out which the penalty and costs., or part of the penalty and all of the costs, can be levied, the Justice or other Court may commit the offender to imprisonment for the term of 30 days, or some part thereof.
4. The "Firearms Bylaw, 1909, No. 81" is hereby repealed.

5. This bylaw may be cited as “**Firearms Bylaw, 1963, No. 3282**”.

READ a first time by the Council on the 17th day of June, 1963.

READ a second time by the Council on the 17th day of June, 1963.

READ a third time and passed by the Council on the 17th day of June, 1963.

RECONSIDERED and finally adopted by the Council, signed by the Mayor and City Clerk, and sealed with the Corporate Seal on the 2nd day of July, 1963.
