THE CORPORATION OF THE CITY OF NORTH VANCOUVER

BYLAW NO. 3308

A Bylaw to regulate Pool-Rooms and Billiard Rooms, within the City of North Vancouver.

The Council of The Corporation of the City of North Vancouver in open meeting assembled enacts as follows:

- 1. No person shall operate any public pool-room or billiard hall within the Municipality of The Corporation of the City of North Vancouver:
 - (a) After mid-night on any Sunday, Monday, Tuesday, Wednesday or Thursday, except between the hour of eight o'clock in the forenoon and the end of the day.
 - (b) After mid-night on any Friday except between the hours of eight o'clock in the forenoon and half past eleven o'clock in the afternoon.
 - (c) After the hour of half past eleven o'clock on the afternoon of Saturday until mid-day on the Sunday immediately following.

- 2. The presence of boys or girls less than 18 years of age in any public pool-room or billiard hall is prohibited, but is permissible until ten o'clock in the afternoon if the premises and operations of the public pool-room or billiard hall are clearly visible through windows fronting on a public street and by lights on the premises, and the presence of boys or girls less than 14 years of age is permissible in such premises only until eight o'clock in the afternoon if accompanied by their parent or legal guardian.
- (a) Any person who violates any provision of this Bylaw shall be deemed to be guilty of an offence against this Bylaw and shall be liable on conviction thereof to a penalty not exceeding \$100.00 with the costs of prosecution.
 - (b) Any Justice of the Peace or other Court before whom the prosecution is had for an offence against this bylaw may convict the offender on the oath or affirmation of any credible witness, and may impose the whole or part of the penalty or punishment authorized by this bylaw with the costs of prosecution.
 - In the event that the penalty, or part of the penalty, and costs imposed under this section are not paid forthwith, the Justice of the Peace or other Court before whom the prosecution was had may, by warrant under the hand and seal of the Justice or other Court, or in case two or more Justices act together therein, then under the hand and seal of one of them, cause the penalty and costs, or the part of the penalty and costs imposed under clause (b), to be levied by distress and sale of the goods and chattels of the offender; and in the case of there being no distress found out of which the penalty and costs, or the said part of the penalty and all the costs, can be levied, the Justice or other Court may commit the offender to imprisonment for the term of 30 days, or some part thereof.

- 4. The City of North Vancouver "Pool Room Regulation Bylaw, 1960" is hereby repealed.
- 5. This Bylaw may be cited, for all purposes, as **"Pool Room Regulations Bylaw, 1963, No. 3308".**

READ a first time by the Council on the 7th day of October 1963.

READ a second time by the Council on the 7th day of October 1963.

READ a third time and passed by the Council on the 7th day of October 1963.

RECONSIDERED and finally adopted by the Council, signed by the Mayor and City Clerk and sealed with the corporate seal on the 21st day of October 1963.
