#### THE CORPORATION OF THE CITY OF NORTH VANCOUVER

#### **BYLAW NO. 4392**

A Bylaw to set aside and dedicate Public Parks certain lands hereinafter described.

**WHEREAS** by virtue of Section 468 of the *Municipal Act* the Council may, without the assent of the electors, by bylaw dedicate for any public purpose any real property owned by the City of an area less than one acre:

WHEREAS those certain lands hereinafter described are owned by the City;

WHEREAS each of the groups of parcels hereinafter described are of an area less than one acre;

**WHEREAS** the Council of The Corporation of the City of North Vancouver deem it desirable to set aside and dedicate for park purposes and recreational grounds each of the groups of parcels hereinafter described;

**NOW THEREFORE** the Council of the Corporation of the City of North Vancouver in open meeting assembled, enacts as follows:

- 1. The lands described as:

2. This Bylaw shall be known and cited for all purposes as "Parks Dedication Bylaw, 1972, No. 4392".

READ a first time by the Council on the 17<sup>th</sup> day of April, 1972.


READ a second time by the Council on the 17<sup>th</sup> day of April, 1972.
