## BYLAW NO. 7192

### A Bylaw to provide for the health benefit coverage of Council Members

The Council of The Corporation of The City of North Vancouver, in open meeting assembled, enacts as follows:

1. This Bylaw shall be known and cited for all purposes as “**Council Health Benefits Bylaw, 1999, No. 7192**”.
2. The Council Members of The Corporation of the City of North Vancouver shall be provided the opportunity to enroll in specified City Management staff Benefit Plans on the same terms and conditions as management staff benefit plans as listed below, it being understood these plans may be amended from time to time for management staff, and by extension under this bylaw, amended for Council members.  
Medical Services Plan  
Extended Health Benefits  
Dental Plan  
Group Life Insurance  
Optional Life Insurance  
Canada Savings Bonds Purchase Plan  
Group RRSP  
Employee and Family Assistance Plan  
Home Computer Purchase Plan  
Employee Fitness Program.
3. The Council members of The Corporation of the City of North Vancouver shall be provided a retirement stipend that provides the Mayor and Council with a lump sum payment at the end of their service on Council, to be payable within 90 working days after the end of service *[Bylaw 8411/2015, adopted Jan 19/15]*. The amount payable will be based on the current rate, at the time, as established by the Pension Corporation, and calculated based on the City’s share of the Municipal Pension Plan contributions for City staff. *[Bylaw 8393/2014, adopted Oct 6/14]*

READ a first time by the Council on the 13<sup>th</sup> day of December, 1999.

READ a second time by the Council on the 13<sup>th</sup> day of December, 1999.

READ a third time and passed by the Council on the 13<sup>th</sup> day of December, 1999.

RECONSIDERED and finally adopted by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal on the 20<sup>th</sup> day of December, 1999.
