HOW WILL THE 2023 DRAFT BUDGET AFFECT ME?

The main source of revenue for the annual budget comes from property taxes and utility fees collected from homeowners and businesses. The amount of municipal tax you pay is dependent on your property type and your property's assessed value.


The City's draft 2023 budget projects a 5.24% increase in taxes on the average home in the City.

Below is a comparison of 2022 total municipal tax and utility charges for an average single detached residence.



HOW DOES MY PROPERTY ASSESSMENT IMPACT MY TAXES?

Between 2022 and 2023, the average residential property in the City, as determined by BC Assessment, increased by 9%. Properties with assessments that rose in line with this average will see a municipal property tax increase of 5.24%, the overall proposed tax rate increase.

If your property's assessed value varies from the average in its property class, your municipal tax rate will either be higher or lower than the proposed tax rate increase.
