# For your convenience, the City of North Vancouver offers a plan for taxpayers to make pre-authorized payments to cover <u>next year's</u> annual tax and utility billing.

### Enroll Today and Take Advantage of the Following Benefits:

- The Pre-authorized Payment Plan allows you to budget tax and utility payments over a 12 month period, instead of making one larger payment.
- The Pre-authorized Payment Plan is a secure means of setting your money aside in advance of the tax and utility billing. It is also secure in that you must authorize the Plan to start and you may stop payment at any time if you feel the necessity to do so.
- The Pre-authorized Payment Plan pays interest on your installments. The interest rate is based on the Bank of Canada prime rate less 2.5% set twice per year on January 1<sup>st</sup> and August 1<sup>st</sup>.

### NOTE:

To avoid penalty, the Home Owner Grant must be claimed prior to the tax due date with the Province of BC at **gov.bc.ca/homeownergrant**. The Pre-authorized Payment Plan is not a substitute for claiming the grant.

**Enrolling in the Plan is Easy.** Simply complete the application form, enclose a personal cheque/bank debit form marked as VOID and mail or drop off the application at City Hall. The application form is also available online at <u>cnv.org/prepaymentplan</u>.

**How Much Can I Pay?** The minimum monthly allowable payment is \$10.00. Your projected monthly payment is shown on the bottom front portion of your tax bill. Each year in August, the City of North Vancouver will automatically adjust the monthly prepayment amount based on the changes in annual taxes. If you are a new owner and/or this is a new property, please contact the City of North Vancouver's Tax Office at **604.983.7317** for a correct calculation of your monthly installment.

### **Terms and Conditions:**

Eligibility: All current year's taxes and utility rates must be paid by the due date of the current year.

**Prepayment Dates:** Eleven equal payments will be withdrawn from your bank account, commencing August 1st each year. The final or 12th payment will be the difference between the actual amount of the current tax bill and prepayments collected, plus interest earned up to the tax due date. This final prepayment will be withdrawn from your bank account on the TAX DUE DATE each year. This final payment will appear on a separate line on your tax notice. Any participants starting after August 1st will have payments prorated equal to the remaining months up to the tax due date. An amount equal to the Annual Flat Rate Utility statement will be transferred from your tax prepayment funds on the due date.

**Year to Year:** Your Pre-authorized Payment Plan direct withdrawal monthly amount will continue and change each year to reflect the current year's taxes and utilities. Your new monthly amount will be reflected on the bottom portion of your annual tax notice. The Pre-authorized Payment Plan is in effect until terminated in writing by the taxpayer/representative and is received by the City of North Vancouver's Tax Office 10 days prior to the next withdrawal.

**Interest Paid:** Prior to the property tax due date, interest on installments paid to the date shall be credited to the benefit of the taxpayer in a special account.

**Avoid Penalties:** You must apply for the Home Owner Grant (if eligible) by July 2, 2025. Your prepayments are calculated net of Home Owner Grant eligibility as stated on the application.

**Changes to your Pre-authorized Payment Plan:** Written notification must be received 10 days prior to the payment withdrawal date. Examples of a change include changes to monthly amounts, bank account information and Home Owner Grant status.

**Cancelling your Pre-authorized Payment Plan/Property Sold or For Sale:** Owners or their representatives must notify the City of North Vancouver to discontinue the Plan before the property is sold. No refund of prepayments will be issued by the City of North Vancouver as a result of owner's failure to discontinue the plan upon transfer of property. Credits must be adjusted between Purchasers and Vendors on Statement of Adjustments.

**Dishonoured Payments:** All dishonoured payments will be subject to a service charge as outlined in the City of North Vancouver Fees and Charges Bylaw. The City may cancel the privilege of continuing in the Pre-authorized Payment Plan if two installments fail to be honoured on the due date by the taxpayer's financial institution. Taxpayers are responsible for notifying the City of North Vancouver's Tax Office of any changes in financial institution, bank account, etc. Written notification must be received 10 days prior to the next withdrawal.

**Recourse Rights:** You have certain recourse rights if any debit does not comply with this agreement. For example, you have the right to receive reimbursement for any debit that is not authorized or is not consistent with this Pre-authorized Payment Plan.
