3. OCP Overview

M. Friesen gave a presentation on the Official Community Plan. The main points included zoning, legislation, land use, community vision and well-being, arts, culture and heritage as well as economic development, municipal services and infrastructure.

Questions and comments from the Commission included but were not limited to:

- Was the OCP amended last year? A: Yes, which included the Northmount Medical building and Harry Jerome with amendments to height.
- Was it changed to accommodate new zoning bylaws? A: The OCP is amended first which allows the zoning bylaw to be updated.
- Is an amendment necessary with most large rezoning projects or is it just density and height? **A:** An OCP amendment is not necessary except for certain key projects. It's important to remember that an OCP isn't meant to be dealt with on a site by site basis. Site planning is an interesting issue in terms of the OCP, it should be considered contextually.
- Please speak to community amenity contributions and how it works, better
 ways of doing it and possible challenges? A: They are dealt with as part of the
 OCP. The density bonus and community amenity contribution policy is updated
 every year. Negotiations are time consuming, contentious and often very
 difficult to determine if it is a good deal or not. Rather than rely on negotiations,
 the City sets a standard dollar figure for any square foot above a certain point.
- Action item: It was recommended to have the CAC policy brought to the committee.
- Some targets are harder to measure, how does an evaluation happen for those, is it based on the municipality or the BC government? **A:** The municipality monitors its own performance.
- M. Friesen described the current zoning policy process and explained max and bonus densities.
- Is there a situation where the FSR is greater than the bonus density to preserve the form on that block? **A:** Density transfer is possible but it should maintain a balance in the City. Heritage properties are preserved with this too.
- What about coach houses? A: They are not exempt.
- How does the OCP factor in plans of other municipalities? A: It can be taken
 into account if the property is adjacent to another municipality. Generally it's
 dealt with at the Metro Vancouver level.
- Is there a list of things that would be included? A: Our policy has certain things that are of value but we don't determine where those contributions should be going.
- Can you comment on the alignment between the zoning bylaw and the OCP?
 A: They are aligned. Our zoning bylaws should be consistent with the OCP.
 Zoning bylaws are extremely challenging documents. When a new development of a certain size is brought forward, we develop specific zones for the site in question. When that happens, staff and Council are able to adapt them to conform to the OCP to a greater degree than the base zones.
