Section 509(5)(b) "Siting (Principal Building)" to reduce the minimum rear yard setback from 0.35 times the lot depth (39.2 feet) to 0.24 times the lot depth (27.7 feet) to permit a portion of the main floor to project beyond the existing rear face of the Principal Building into the northern rear yard setback;
