THAT the application of Majid Forouzandeh Bakhsh and Akram Jounibeik, Owners, representing the owners of 753 East 18th Street, North Vancouver, BC, and legally described as Lot E, Block 6, DL 616, Plan 15899, requesting a variance to "Zoning Bylaw, 1995, No. 6700", Part 5: Residential Zone Regulations:

- Section 514(5) "Siting (Accessory Buildings)" (a) be varied to reduce the required 1.22 metre (4 feet) setback from the Rear Lot Line to 0.4 metres (1.4 feet) for the deck and 1.16 metres (3.8 feet) for the wall of the proposed Accessory Building to the Rear Lot Line;
- 2. Section 514(5) "Siting (Accessory Buildings)" (e) be varied to reduce the required 0.61 metre (2 feet) setback from the eastern Interior Side Lot Line to 0.4 metres (1.4 feet) for the deck and 0.55 metres (1.8 feet) for the wall of the proposed Accessory Building to the eastern Interior Side Lot Line;

be **GRANTED** as per the plans submitted to the City of North Vancouver dated May 9, 2017.
