2. Variance: 341 Tempe Crescent, North Vancouver, BC

The applicant presented a variance request that would allow the Height Envelope to be 22.5 feet (an increase from the 15 feet allowed by the Zoning Bylaw).

THAT the application of Mason Kent, Mason Kent Design, representing the owners of 341 Tempe Crescent, North Vancouver, BC, and legally described as Lot 4, Block 236, DL 546, Plan 3292, requesting a variance to "Zoning Bylaw, 1995, No. 6700", Part 5 Residential Zone Regulations:

 Section 509(4) "Height (Principal Building)" (a) be varied to state the Height Envelope shall not exceed 6.86 metres (22.5 feet) which may increase at an inward angle of 45 degrees to the horizontal to be higher than the geodetic height of the top of plate of any Storey, to reach a maximum of 9.14 metres (30 feet)

be **GRANTED** as per the plans submitted to the City of North Vancouver dated February 9, 2018.
