New Museum

- First Nations Partnerships Update
   At a meeting with Leonard George Mr. Hood discussed obtaining a support letter
   for the new museum at Site 8. A support letter from the Aboriginal Tourism
   Association will be forthcoming. There is an interest in establishing a North
   Vancouver Aboriginal Cultural Partnership including the Polygon Gallery.
   Speakers and letters supporting the new museum are expected for the Public
   Hearing.

#### 5. REPORTS

Director's and Museum & Archives Operations Reports

- Shipyards Theatrical Interpreters have commenced working with the contracted theatre specialist and will conduct public tours at the Burrard Dry Dock site and Lynn Canyon during the summer months.
- A successful launch of *The Native Voice* took place on June 9, 2016. The book which was written by former Commissioner Eric Jamieson emerged as a result of the Entwined Histories exhibit. A small exhibit of Maisie Hurley's art work and items from her collection were on display. Chief Dr. Robert Joseph of the Truth & Reconciliation Commission and Mr. Tom Berger, former Supreme Court Justice, both shared personal reminisces of Maisie Hurley.
- June 22 and June 25, 2016 book launches of *Where Mountains Meet the Sea* will take place at the Lynn Valley Library. The book was an initiative of the NVMA which helped coordinate funding and contributions to the book, with most of the illustrations in the book coming from the North Vancouver Archives.
- The online Walter Draycott exhibit (greatwarchronicle.ca) is being automated by a computer science student hired through the student grant program *Young* Canada Works. The Curator has a student researcher hired through the grant program Canada Summer Jobs via the Friends Society for the Chief Dan George exhibit.
- Noteworthy acquisitions: A woven Coast Salish cedar briefcase similar to one in a photo taken in 1906 when Chief Joe Capliano visited London has been purchased at auction by the NVMA. Don Bourdon donated a scrapbook showing the Tipperary Tea Garden.
- The Water's Edge interactive exhibit at Presentation House is generating positive feedback, and is proving to be so popular time limits for users may be considered.

#### Governance Committee

A decision by City Council on the impact of Post-Employment Benefits for NVMA staff on the Commission's financial statements will be taken on June 20, 2016. The recommendation from CNV staff is to show the liability on the CNV financial statements. This will result in the previously reported surplus for the NVMA to be retained. The District finance department staff have approved this course of action. Commissioners will work with City staff to resolve this matter.

# Friends Society

The Society elected two new Directors at their Annual General Meeting held June 14, 2016. The Museum Director made a presentation on the New Museum at the AGM.
