

VOLUNTEER REQUIREMENTS

BASIC REQUIREMENTS

In order to become a volunteer at an RCMP Community Policing or Crime Prevention Centre, applicants must be able to fulfill these minimum requirements:

- Be nineteen (19) years or older at the time of application
- Commit to a minimum of one (1) year service. Provide at least three (3) hours per week and be able to attend all required training sessions and meetings
- Hold a BC Driver's Licence (required only if interested in programs that require the use of a Community Policing vehicle)
- Have and maintain a clean driving record for the past five (5) years
- Must not be under investigation by any police force
- Consent to a criminal record and background check
- Take an Oath of Confidentiality
- Have the ability to write and communicate well in the English language
- Be a Canadian Citizen or Landed Immigrant

ADDITIONAL QUALIFICATIONS

Additional qualities that we look for in a potential volunteer:

- Have an interest in aiding the general public and serving his/her community
- Be mature, responsible and reliable at all times
- Be of good moral character
- Exercise good judgment and common sense
- Show an ability to handle situations in a calm, non-judgmental and non-prejudicial manner
- Present himself in a professional demeanor and adhere to the prescribed dress code
- Take direction well while still able to think independently
- Demonstrate patience with members of the public who use the community policing/crime prevention centres
- Be able to gather adequate and accurate information from clients

VOLUNTEER PROGRAMS

These are a few of our volunteer programs

The **Business Link** Program invites businesses to join in this active and informative program. The intent of this program is to prevent and reduce the incidents of criminal and suspicious activity. Businesses receive online Newsletters with crime prevention tips and information, online Alerts/Fanouts as needed and Quarterly Newsletters delivered by volunteers. Volunteers also visit each business regularly documenting any issues or crime related problems they may be having. Reports are given to the Office Coordinator and if needed sent to the Response Sergeants for their action. Businesses also can request training in a variety of crime prevention areas such as Counterfeit Currency, Robbery Prevention, Shoplifting, etc.

The **Lock Out Auto Crime** objective is to generate vehicle owner awareness of measures to protect their vehicles from theft or vandalism as well as provide a visible presence in the area. Volunteers visit parking lots in popular visitor attraction sites such as Grouse Mountain and handout Lock Out Auto Crime brochures.

The **Speed Watch** program uses the Centre's Speed Watch van which is equipped with portable radar equipment and an electronic digital board. Volunteers monitor speeds in neighborhoods, particularly school and playground zones. Drivers get an instant readout of their speed, displayed on a reader board as they pass by. Volunteers record the speed of every vehicle and monthly statistics are forwarded to ICBC, RCMP Traffic Section and requesting agency (such as the District of North Vancouver Engineering Dept.).

The **North Vancouver Citizens Crime Watch** is a group of concerned citizens who volunteer their time to assist in the fight against crime. Their motto is **OBSERVE, RECORD, REPORT**. The volunteers support the RCMP by patrolling designated areas watching for any possible criminal activity. Patrols are made in the Community Policing vehicles. The patrols are mainly done on Friday nights from approximately 8:00 pm to midnight.
