1. INTRODUCTION OF BYLAW

Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2013, No. 8309

SYNTHESIS DESIGN has applied to rezone Lot B, Block 257, DL 544, Plan 14450 located at **2211 Larson Crescent**. The amendment to "Zoning Bylaw, 1995, No. 6700" will have the effect of reclassifying the said property

- **FROM:** RS-1 (One-Unit Residential) Zone
- TO: CD-639 (Comprehensive Development 639) Zone

to permit the subdivision of the existing lot into two parcels with a single family home on each new lot. Each lot would provide two enclosed stalls and one unenclosed surface stall for a total of 3 stalls each. All parking would be accessed from the rear lane.
