Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2013, No. 8312

**BILL CURTIS & ASSOCIATES DESIGN LTD.** has applied to rezone Lot 20, Block 47, D.L. 271, PLAN 1658 located at **330 West 14<sup>th</sup> Street.** The amendment to "Zoning Bylaw, 1995, No. 6700" will have the effect of reclassifying the said property

FROM: RS-1 (One-Unit Residential) Zone

**TO:** CD-641 (Comprehensive Development 641) Zone

to permit a new two-unit dwelling that fronts West 14<sup>th</sup> Street and a new one-unit dwelling at the rear of the lot, for a total of three dwelling units. Three enclosed vehicle parking stalls attached to the rear unit plus two surface parking stalls will be accessed from the rear lane.
