- Robin Newton, 2104 Grand Boulevard, North Vancouver, expressed concern for the redirection of funds from the Affordable Housing fund to the General Infrastructure fund.

THAT the request (New Item #8) from the North Vancouver School District, for an increase in funding for the School Crossing Guard Program in the amount of \$23,800, consisting of \$8,200 for salary increases for existing locations and \$15,600 for an additional crossing guard location at Moody Avenue and East 19th Street for Queensbury Elementary School, be supported;

THAT any identified savings not used to fund new items be redirected to general infrastructure funding;

THAT the \$260,000 current contribution to the Affordable Housing Fund be redirected to general infrastructure funding;

AND THAT an additional 1.00% be levied and set aside for the redevelopment of Harry Jerome Community Recreation Centre.
