B. Mondizadeh / Domustix Development Corp., have applied to rezone Lot 4. except the north 15 feet, Block 29, DL 548, Plan 957, located at 1616 Mahon Avenue. The amendment to "Zoning Bylaw, 1995, No. 6700" will have the effect of reclassifying the said property:

FROM **RS-1 (ONE-UNIT RESIDENTIAL 1) ZONE** 

TO CD-652 (COMPREHENSIVE DEVELOPMENT 652) ZONE

to permit the construction of a new duplex with two accessory dwelling units (secondary suites). A total of four parking stalls are proposed, with vehicle access from the lane.
