1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2014, No. 8395"

(North Lake Ventures Inc./Rafii Architects Inc., 141-147 East 21st Street, CD-658)

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2014, No. 8395" will have the effect of reclassifying the said property:

- **FROM:** RM-1 (Medium Density Apartment Residential 1) Zone
- TO: CD-658 (Comprehensive Development 658) Zone

to permit a six-storey, 107-unit rental apartment building. A density bonus of 1.0 FSR for the provision of rental housing in perpetuity is proposed. Residential parking will be provided underground and visitor parking is proposed to be accessed from the rear lane.
