1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2015, No. 8409" (Signal Investments Ltd. / H.R. Hatch Architecture Ltd., 1549 St. George's Avenue, CD-660), will have the effect of reclassifying the said property:

FROM: RM-1 (Medium Density Apartment Residential 1) Zone

TO: CD-660 (Comprehensive Development 660) Zone

To permit the addition of new third and fourth floors to create a four-storey apartment building with 29 rental units. A density of 2.1 times the lot area is proposed, of which 0.46 is a requested density bonus for the provision of market rental housing. A parking variance is proposed to reduce the number of required vehicle parking spaces to six.
