"Official Community Plan Bylaw, 2014, No. 8400, Amendment Bylaw, 2015, No. 8431" would reduce the required commercial floor area in the Harbourside Waterfront area for the purpose of permitting a Seniors' Assisted Living Facility.

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2015, No. 8432" would permit a Seniors' Assisted Living Facility and Seniors' Rental Housing on the northern portion of 18 Fell Avenue and 925, 889, and 801 Harbourside Drive, with an associated reduction in parking. The application will reconfigure residential and commercial density between the CD-646 sub-areas with no overall increase in site density.
