1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2015, No. 8426" would rezone the property located at 1745 Mackay Avenue, from RS-1 (One-Unit Residential 1) to RS-3 (One-Unit Residential 3) to allow the subdivision of the property into two lots. Each lot would include a single family home with an accessory secondary suite and two enclosed vehicle parking spaces accessed from West Keith Road.

"Development Variance Permit No. DVP2015-00008" would allow the proposed 1.2-metre (4 foot) interior side lot setback from the subdivision line and a 5.6 metre (18.5 foot) height envelope with a maximum ridge height of 9.8 metres (32 feet).
