"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2015, No. 8435" (S. Azizbaigi and A. Ostadsaraie / Vernacular Design Inc., 212-214 West 5th Street, CD-664)

This bylaw would permit the rezoning of this property from Two-Unit Residential 1 (RT-1) Zone to Comprehensive Development 664 (CD-664) Zone in order to construct three buildings, each with one dwelling unit, at a combined Floor Space Ratio of 0.75 times the lot area within a height envelope of 5.5 metres (18 feet) to a maximum of 9.14 metres (30 feet). Four vehicle parking stalls would be accessed from the rear lane.
