1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2016, No. 8487" (Marco M De Cotiis / KCC Architecture and Design Ltd., 365 East 14th Street, CD-673) would rezone the subject property from a One-Unit Residential (RS-1) Zone to a Comprehensive Development 673 (CD-673) Zone in order to permit the development of a new duplex at the rear of the site that will retain an existing Single Family Home. The proposed density for the property is 0.49 times the lot area (FSR). The application requires a variance to the location of an existing accessory building.
