Development Variance Permit No. DVP2016-00002 (150 East 8th Street) would vary the maximum height and height exceptions set out in the Zoning Bylaw, Sections 409 and 513(3), to permit the construction of a 17.4 metre high roof with 7.62 metre high generator equipment on top of the roof, and to vary Section 512(4) to allow the existing zero metre setback from the front and eastern interior lot lines to remain. These variances are required in order to facilitate upgrades to the existing Telus Communications building.
