1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2016, No. 8570" (J. & L. Kornafel / Bill Curtis & Associates Design Ltd., 605 East 22nd Street) would rezone the subject property from a One-Unit Residential 1 (RS-1) Zone to a One-Unit Residential 3 (RS-3) Zone to permit the subdivision of 605 East 22nd Street into two lots, each a minimum of 4,800 sq. ft. A new one-family dwelling with a secondary suite would be built on each lot. The proposed density is 0.5 times the lot area. Variances to the driveway and accessory building location on the western lot are also proposed.
