"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2017, No. 8564" (Onni Contracting Ltd., 1308 Lonsdale Avenue, CD-631 Text Amendments) would amend the existing zoning for this property to permit a Below-Grade Commercial Social Recreation Facility. This amendment would facilitate a proposed bowling alley and allow for floor area used for Below-Grade Commercial Social Recreation Facility to be excluded from the total Gross Floor Area for the property.
