PUBLIC HEARING – Rooftop Antenna Development Permit Area Guidelines

1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2017, No. 8484" (Rooftop Antenna Development Permit Area Guidelines) would introduce a limited height exception for Third Party Wireless Antenna Systems on Principal Buildings in specific land use categories (mixed use, high density residential, commercial and industrial). The Bylaw will also establish Development Permit Area Guidelines.

"Development Procedures Bylaw, 2001, No. 7343, Amendment Bylaw, 2017, No. 8485" (Rooftop Antenna Development Permit Area Guidelines) would add Rooftop Antenna Development Permit Area Guidelines and associated fees to the Application list within the Development Procedures Bylaw.
