1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2018, No. 8611" (Cascadia Green Development / Vivid Green Architecture, 230-232 East 8th Street, CD-698) would rezone the subject property from a Two-Unit Residential 1 (RT-1) Zone to a Comprehensive Development 698 (CD-698) Zone to permit the development of six 3-storey townhouse units including 4 accessory lock-off units. The proposed density is 0.75 times the lot area (FSR), with a maximum building height of 32.5 feet.
