PUBLIC HEARING - 123-127 and 145 East 13th Street

1. INTRODUCTION

"Official Community Plan Bylaw, 2014, No. 8400, Amendment Bylaw, 2021, No. 8832" (Millennium Northmount Nominee Ltd., Inc. No. BC1120079, 123-127 and 145 East 13th Street, Permitted Height Change) and "Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2021, No. 8833" (Millennium Northmount Nominee Ltd., Inc. No. BC1120079, 123-127 and 145 East 13th Street, CD-004 Text Amendment) would amend the maximum height permitted by the OCP to allow for a 1.7 metre increase in height, as well as several minor amendments to the CD-004 Zone. An OCP amendment and rezoning was approved for the redevelopment of this site in 2018 for an 18-storey commercial and residential building. The proposed design remains unchanged, with the exception of additional floor-to-ceiling height on the commercial office levels and improvements to the ground floor grading, for a total height increase of 1.7 metres. Other proposed amendments support elements of the original design that were not captured in the original CD Zone.
