## PUBLIC HEARING - 705 West 3rd Street

### 1. INTRODUCTION

"Zoning Bylaw, 1995, No. 6700, Amendment Bylaw, 2021, No. 8839" (Marine and Bewicke Project Ltd. / Ankenman Marchand Architects, 705 West 3<sup>rd</sup> Street, CD-735) would rezone the subject property from a Service Commercial (CS-1) Zone to a Comprehensive Development 735 (CD-735) Zone to permit the development of a 6-storey, 70 market rental unit apartment building, above a commercial ground floor that is proposed to be occupied by a child care facility. Two levels of underground parking for 87 vehicles are proposed. The proposed density is 2.60 times the lot area.
