**1. INTRODUCTION**

**Official Community Plan, Bylaw, 2014, No. 8400**

(A Bylaw to Establish a New Official Community Plan)

This bylaw will have the effect of rescinding the current City of North Vancouver Official Community Plan and replacing it with a new Official Community Plan, including an updated Regional Context Statement. The Official Community Plan is the City's long-range planning tool for guiding the growth and development of the City. It includes a broad vision for the community's future, with supporting goals and objectives. The Official Community Plan applies to the entire City. Major policy areas and chapters within the Official Community Plan include:

- Foundation (Community Vision)
- Land Use/Density
- Transportation, Mobility and Access
- Community Well-Being
- Natural Environment, Energy and Climate
- Parks, Recreation and Open Space
- Arts, Culture and Heritage
- Economy and Economic Development
- Municipal Services and Infrastructure
- Regional Context Statement (Alignment with the Metro Vancouver Regional Growth Strategy)

- Increase to height and density for the 200 block of East 15th Street (north-side); and the 1500 block of Eastern Avenue (east-side) (see Schedule A - Land Use Map).
