BLOCK PARTY PERMIT CONDITIONS

- 1. Shall erect barricades supplied by the City of North Vancouver and shall ensure that the barricades remain in place and that they are staffed at all times.
- Shall accept full responsibility for any accident that may occur or damage that may be done to any
 person or property whatsoever caused directly or indirectly by the Block Party event and shall save
 harmless and keep indemnified the City from all claims and demands whatsoever that may arise as a
 result of this event.
- 3. Shall notify all the affected neighbours on the block two weeks prior to the event and obtain approval from 2/3 of affected neighbours.
- 4. Shall pay the fee set out under Schedule H of the Fees and Charges Bylaw No. 9000 (Block Parties organized by the North Vancouver Block Watch Program are exempt from this processing fee).
- 5. Shall obtain Liability Event Insurance from the Field Allocator at the Recreation Commission, 851 West Queens Road (604-983-6318). The cost for the Liability Event Insurance is \$47.00 per event (subject to change without notice).
- 6. Shall comply with the Noise Control Bylaw.
- 7. Shall provide a minimum of ten (10) business days' notice or to the Engineer's discretion prior to the commencement of the permit.
- 8. Block parties must take place between the hours of 10:00 a.m. and 8:00 p.m.
- 9. Block parties should be planned for Saturdays, Sundays and Statutory Holidays.
- 10. Alcohol is not permitted on public property.
- 11. Fireworks are not permitted.
- 12. Access must be maintained for emergency vehicles.
- 13. Loud amplification of music is prohibited.
- 14. Cleaning up is the responsibility of the organizers.
