- was once allowed in City Library as long as dog was in carrier;
- agrees dogs shouldn’t be allowed to run around in public places;
- she has proper equipment to take her dog on the bus;
- if people contain their dogs properly, don’t see why they can’t be brought into public places;
- would like to know if there are any other means to enable her to go around with her dog;
- would like to know the dates when Council will sit down and look at their budget. Is Council going to consider freezing wages; what is Council prepared to do to pull in its budget?

THEREFORE BE IT RESOLVED THAT City staff be requested to obtain, at Port Metro Vancouver’s expense, new independent studies by professional air quality and noise consultants based on criteria to be established by the City Engineer, to establish appropriate base lines before construction begins and to be repeated for comparison purposes one year after project completion and used to determine future mitigation measures if needed.”
